## ELD & AVAILABLE TRUCKS LOOM AS POSSILE PROBLEMS AHEAD

The trucking industry is predicting very tight truckload availability by Spring 2018. Several factors including last year's hurricanes, this year's brutal winter weather and the ELD (Electronic Logging Device) mandate are the major factors influencing truck capacity availability.

Shippers are feeling the pinch already. The ELD mandate enforcement officially started on January 1, 2018 and some independent truckers have threatened to strike. Part of the controversy is that ELD's limit unfairly, the hours a driver may log and may cause drivers to stop a half-hour short of their delivery and/or cause drivers to speed, just to get from point A to point B within the allotted hours.

Others just see it as a wave of the future with the electronic logging devices and don't see the

impact as being all that bad. It's just a learning curve and a time of adjustment. The true goal is to make the roads safer for both truckers and the general public, but right now the immediate future seems uncertain.

Enforcement personnel have been trained and will be verifying hours-of-service compliance by reviewing records of duty status requirements electronically. On April 1, 2018 inspectors will start placing commercial vehicle drivers out of service if their vehicle is not equipped the required ELD.

A number of independent drivers are simply parking their trucks and calling it quits. All of this is putting a strain on the availability and the cost of the availability. Many are predicting sharp increases in freight rates in the near future along with a very tight truck capacity.


